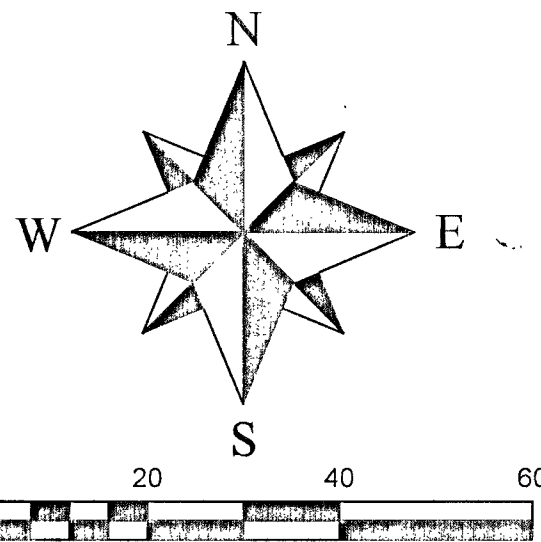

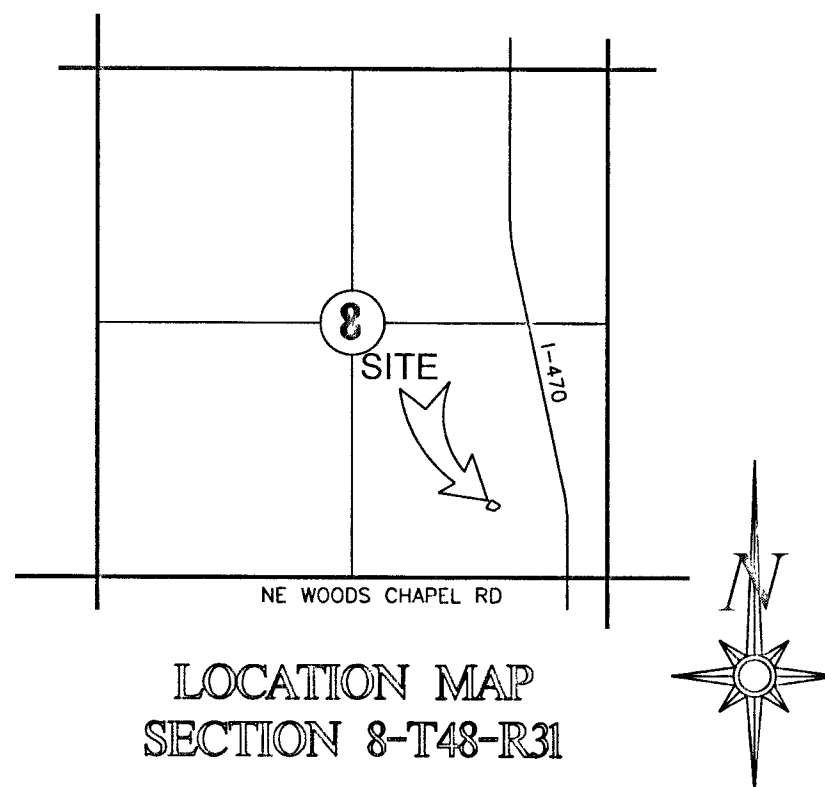

EASEMENTS:

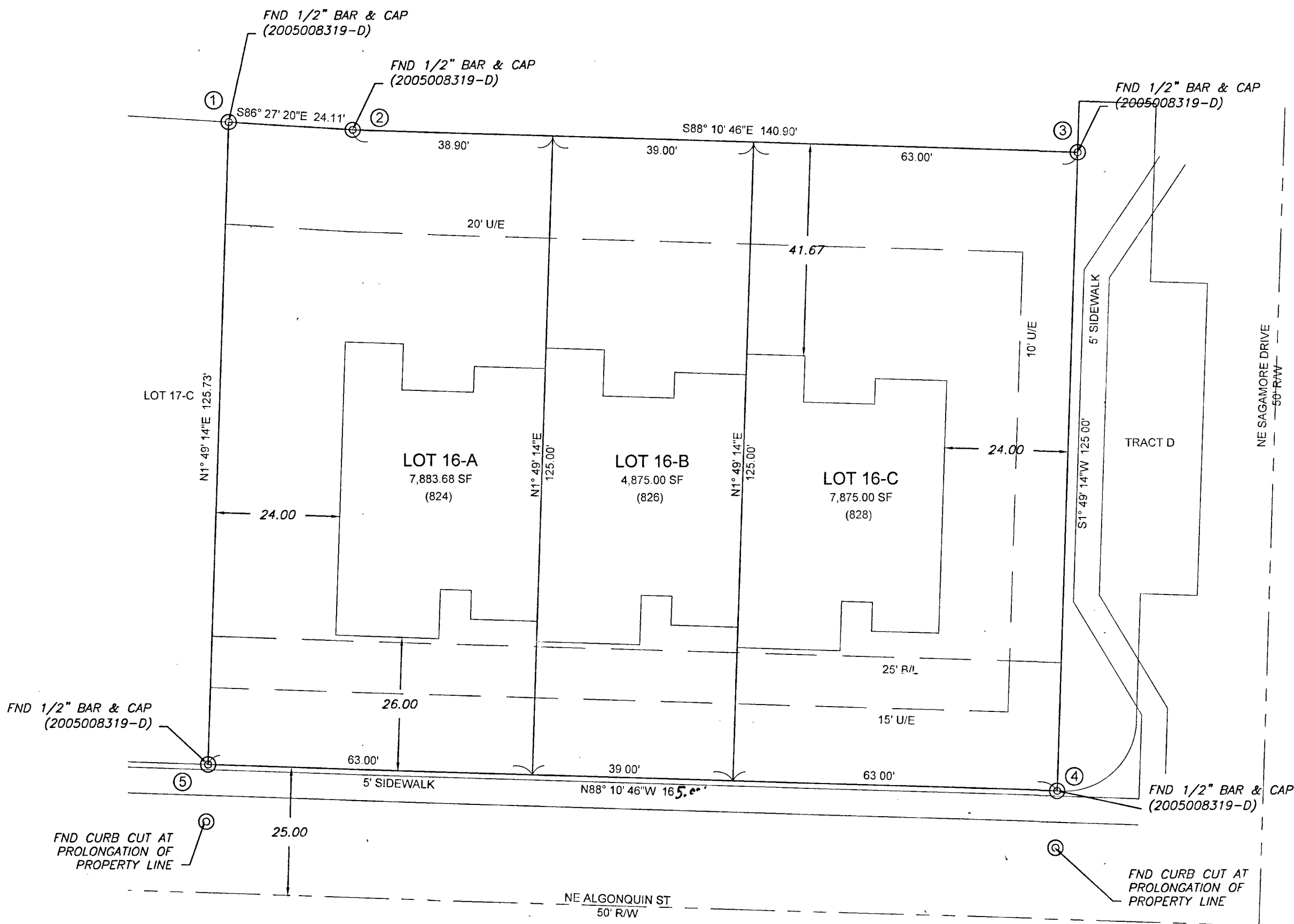

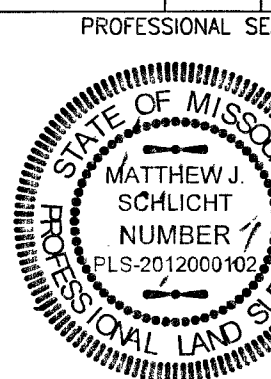
