- 1. Refer to previous applicant letter. Field inlet openings were requested on the plan view. This can be done by showing cardinal directions for each opening, and labeling each field inlet. Correction required.
- 2. Reviewing the plans further, I do not see any profile view for the junction box connection to the underground detention system. Evaluate and revise if necessary.
- 3. MoDOT approval of the plan required prior to formal approval. Recommend turf reinforcement mat, but that will be up to MoDOT. Informational comment.
- 4. Cost estimate required prior to formal approval. The estimate shall consist of all anticipated sitework less any lighting, decorative landscaping, building, handrails, or other items not reviewed and inspected by Development Engineering. Informational comment.
