The applicant proposes to vacate an approximately 600' long section of SW Jefferson St right-of-way (plus connected miscellaneous right-of-way) south of SW Oldham Pkwy. The vacated section of SW Jefferson St is proposed to be relocated to the west as part of the future Oldham Village commercial development. Please see the accompanying legal description and exhibit for the right-of-way to be vacated.

Additionally, the applicant proposes to vacate an approximately 196' long section of SW Market St (approx. 21,832 sq. ft.) adjacent to 1300, 1302 and 1304 SW Market St.
