- 1. STREET NAMES. 1) The east-west segment of the "7" road shall have the name changed from SW Fieldhouse Dr to SW Oldham Xing (Xing representing an abbreviation of Crossing). 2) The north-south segment of the "7" road shall have the name changed from SW Jefferson St to SW Jefferson Xing. 3) The street name suffix for SW Fieldhouse Dr contained within Tract D shall be changed to Xing, so the named private drive is SW Fieldhouse Xing.
- 2. ADDRESSES. 1) Update the street name portion of the labeled addresses for Lots 8-10 and Tract C to reflect the correct street name of SW Jefferson Xing, not Jefferson St. 2) Add an additional label to make it clear that Tract D is addressed as 241 SW Oldham Pkwy. 3) Staff has re-sent all draft address to our Fire Dept and GIS group to get final approval. Any further address revisons will be provided, if necessary.
- 3. CITY SIGNATURE BLOCK. Update the Planning Commission Secretary's name from Terry Trafton to Charles E. Touzinsky, III.
