City of Lee's Summit 220 SE Green Street Lee's Summit, MO 64063 AN ORDINANCE VACATING A 60'-WIDE STRIP OF RIGHT-OF-WAY (SE GREEN STREET LOCATED BETWEEN SE  $2^{ND}$  STREET AND SE  $3^{RD}$  STREET) AND VACATING A 20'-WIDE STRIP OF RIGHT-OF-WAY (UNNAMED ALLY) LOCATED BETWEEN SE GREEN STREET AND SE JOHNSON STREET, IN THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, the subject rights-of-way were dedicated via the plat titled WB Howards 1<sup>st</sup> Addition in 1867; and,

WHEREAS, Application #PL2024-082, submitted by the City of Lee's Summit, requesting vacation of the rights-of-way, was referred to the Planning Commission to hold a public hearing; and,

WHEREAS, after due public notice in the manner prescribed by law, the Planning Commission held a public hearing for the request on September 12, 2024, and rendered a report to the City Council containing findings of fact and recommending that the requested vacation of right-of-way be approved; and,

WHEREAS, after due public notice in the manner prescribed by law, the City Council held a public hearing on October 8, 2024, and rendered a decision to vacate said rights-of-way.

SECTION 1. That the following described rights-of-way are hereby and herewith vacated:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

Green Street to be Vacated Description:

All that part of Green Street right of way lying Southeast of the Southeast right-of-way line of 2nd Street, as now established and lying Northwest of the Northwest right-of-way line of 3rd Street, as now established, lying in the Southwest Quarter of Section 5, Township 47 North, Range 31 West, all being in the City of Lee's Summit, Jackson County Missouri, being more particularly described by Patrick E. Ward, MO PLS-2005000071, of Olsson, Inc., Missouri LC-366, on June 13, 2024, containing 31,218 Square Feet or 0.7167 acres, more or less.

20' Alley to be Vacated Description:

All of a 20 foot wide Northeast-Southwest alley lying Southeast of Lots 6 – 10, and Northwest of Lots 1 – 5, Block 18, W.B. Howard's Addition to the Town of Strother, lying in the Southwest Quarter of Section 5, Township 47 North, Range 31 West, in the City of Lee's Summit, Jackson County Missouri, being more particularly described by Patrick E. Ward, MO PLS-2005000071, of Olsson, Inc., Missouri LC-366, June 13, 2024, containing 8,003 Square Feet or 0.1837 acres, more or less.

SECTION 2. That the vacation of rights-of-way shall be in accordance with the exhibits and legal descriptions dated June 13, 2024, appended hereto as Attachment A and Attachment B, respectively, made a part hereof.




